BOARDING TERMS & CONDITIONS

The daily rate is \$ _____ per day. THE DAY OF DROP OFF IS ALWAYS CHARGED IN FULL. The day of Pick up is charged at half price if pick up is before noon. NOT INCLUDED ARE HOLIDAYS & PEAK TIMES. SUNDAYS ARE ALWAYS CHARGED IN FULL. Int. _____

EARLIER THAN COMMITTED PICK UPS, DURING HOLIDAYS & PEAK TIMES, WILL BE CHARGED FOR THE FULL PERIOD RESERVED. (72-hour notice may enable us to rebook space and eliminate early return charges.) Int. _____

Items left with your pet may not be returned. If returned, they may be in poor condition. We are not responsible for these items or their condition. Should bedding, left with your pet require cleaning, charges for laundering will be applied at \$2.00 per item. We also provide extra bedding upon request. Int. _____

AGGRESSIVE PETS — Pets determined to be aggressive or otherwise difficult will be charged an extra handling fee of \$5.00/ day at a minimum. Should your dog injure a staff member, customer or another dog, you will be held liable and responsible for any costs incurred. Int. _____

GROUP PLAY — Should you desire that your pet participate in group play, the rate is \$5.00 per day. Please refer to the Group Play contract for more details. Int. _____

BATHING & GROOMING — All pets that stay with us for 4 days or more, may receive a mini bath (\$10.00 to \$50.00). Mini baths are given by our boarding staff. Additional grooming services such as: nails, brush, undercoat, pads, trims, glands etc. can be requested at check in. Int. _____

BORDETELLA — Bordetella is a common ailment, which can be contracted any time there are multiple pets together. A like comparison is to equate Bordetella to colds and flue that our children contract when they go off to school, summer camp, or day care. In an effort to guard against this ailment in our Resort, it is standard policy that each pet owner provides proof of Bordetella revaccination every 6 months. Int. _____

INTESTINAL UPSET — Through the years, we have developed a well-balanced, easily digestible diet that we provide to our guests. If your pet is not on a veterinarian prescribed diet, we HIGHLY recommend that you allow us to provide the food for your pet. Our diet is proven to reduce a pets' chance of developing intestinal track upset. If you not use our diet and your pet experiences intestinal track upset that results in medication, the need of a veterinarian or extra staff handling and cleanup, all fees and expenses will be passed to you at check out. Int. _____

DESTRUCTIVE BEHAVIOR — In the event that your pet destroys any of our furnishings you will be asked to cover replacement costs—not to exceed \$100.00. Int. _____

INFESTATION — Pet's entering this resort must be free of fleas and ticks. If your pet enters our resort with fleas or ticks you will be assessed an infestation fee of \$50.00. Other fees may also apply such as personal handling of your pet to remove fleas or ticks, the application of prevention products, dips and any other measures that must be taken by the resort in order to stop an infestation. ABANDONMENT — State statutes consider pets to be abandoned if not picked up by the owner(s) after 10 days following the arranged pick up date. Abandoned pets will either become the property of the local animal shelter or adopted without Resort liability. Int. _____

Our first and foremost concern is the best interest of your pet. In order to provide the best boarding experience for your pet, we reserve the right to alter programs or care for your pet. Any such alterations that result in extra costs will be passed to you. Int. _____
